2011 IN REVIEW

In 2011, the McKenna Foundation issued grants to 42 nonprofit organizations for a total of **\$2,729,269** for community resources ranging from student dropout prevention programs to development of an affordable home ownership neighborhood for New Braunfels families.

Efficient but effective. Nonprofit organizations are constantly striving toward the goal of using their precious resources for maximum benefit of the population they serve. Fortunately, McKenna helps local nonprofits move toward this goal in ways other than financial support through grant making. We help them from the ground up by lessening or eliminating some of their basic operating expenses that are required but not directly program related.

Nonprofits can utilize space for meetings, trainings or fundraisers within the McKenna Events Center at no charge or a nominal fee. In 2011, room rental donations and discounts saved 60 local nonprofits \$235,400 in facility rental fees which could be redirected toward their mission-based programs for the community.

Support for building Information Technology capacity is also provided through grants and by McKenna staff at no charge. McKenna assistance with computer hardware, software, phones, websites and other Information Technology needs saved 10 local nonprofits \$116,338 in 2011.





MEETING NEEDS

■ AARP Foundation Tax-Aide McKenna supports local nonprofit organizations by trying to understand the scope of their operational needs. Consistently, nonprofit staff voiced the need for accessible, low cost meeting space. As a multi-purpose community facility in downtown New Braunfels that can accommodate groups small and large, the McKenna Events Center was opened to local nonprofits for no charge or a discounted rate to fill this need.

Whether it is a board meeting, continuing education workshop or large annual fundraiser, local nonprofits can coordinate with McKenna Events Center staff to execute their perfect event. This can allow these organizations to meet multiple goals. By eliminating facility rental cost from their budgets, organizations improve their bottom line with the freedom to use these funds toward directly serving our community. The availability of McKenna Events Center gives some a fresh, high-tech space to exchange ideas and strategically plan for the future during board meetings. Community education workshops and services are held in spacious rooms with plentiful restroom and parking facilities which improves overall service delivery.

In 2011, the McKenna Events Center provided **\$235,400** in no-charge and discounted space rental to **60** local nonprofit organizations, including:

NON PROFIT

New Braunfels Kids' Club Technology progresses whether you have the funds to keep up with the latest hardware and software or not, and many local nonprofits neglect advancement of their Information Technology systems for the benefit of those in need in our community. In turn, McKenna provides Information Technology capacity building grants and services to those nonprofit organizations whose systems need an upgrade.

Big Brothers Big Sisters of Comal and Guadalupe Counties needed tools to make presentations to local organizations and recruit professional volunteer mentors for at-risk kids. McKenna gave them a laptop, portable projector and screen to take their message on the road.

Kids' Club needed computers to help the kids in their after school program with their homework and continuing education. McKenna gave them 14 desktop computers and software to keep the kids on-line.

CASA of Central Texas needed document management software to organize their confidential paperwork and assist their advocate volunteers in completion of court-ordered reports on kids in the Child Protective Services system.

McKenna funded their system upgrade and opened up their virtual world.

Options for Women needed a way to disseminate their parenting education material in-house and advance their website to meet the needs of a young, tech-savvy generation. McKenna provided televisions and bluray players to help new moms and dads as well as development of a refreshed website that vulnerable, scared, pregnant teens can trust.

These are four examples of the **10** organizations who received **\$116,337** in Information Technology grants and services from McKenna in 2011.

GRANT GUIDELINES & APPLICATION PROCEDURES

In 2011 the McKenna Foundation welcomed applications from any 501(c) (3) nonprofit organization that served residents of the New Braunfels area with health, education, or well-being services. Grant applications were accepted for funding of existing or new programs.

The grant calendar was introduced early in 2011 which included an application submission deadline of March 18th. Application forms were posted online at mckennalegacyfoundation.org for easy review and download. Nonprofit organizations were invited to contact a Program Director with any questions concerning the application process.

McKenna Foundation Program Directors conducted site visits of all qualified applicants. Applications were reviewed by the Grants Committee and submitted to the McKenna Foundation Board of Trustees in June. The Board made all final decisions regarding funding, and each applicant received written notification of their funding decision. Awarded grant payments were issued in July.
